

Guidelines for Submission of Internal Assessment

- 1.** There are 20 marks allotted for internal evaluation (Two Assignments) for each subject of 3 Years LL.B and 5 Years B.A., LL.B., during each semester. Assignments will be given and evaluated by the concerned Lecturer.
- 2.** The assignments should be handwritten on normal A4 white sheets, which should cover all the aspects of the assignment.
- 3.** Students are directed to submit all assignments in person on or before 11th September, 2023.
- 4.** Assignment submitted after the last date for submission will not be accepted.
- 5.** It is compulsory to submit all assignments at once and individual assignments will not be accepted, failing which the student will not be assessed for internal evaluation and the student may lose internal marks.
